Proposed grant funded sub-recipient agreement between the City of Baton Rouge, Parish of East Baton Rouge, on behalf of the Baton Rouge Police Department, Jazzi Solutions, LLC funded through the FY 2020 Justice Mental Health Collaboration Program for the purpose of establishing the Baton Rouge Mental Health Response Team in the sum not to exceed \$40,000.00 effective January 1, 2021, and terminating September 30, 2023. **(By: Police Department)**
