A proposed resolution was read in full.

RESOLUTION 56091

**APPOINTING A REPLACEMENT TO FILL THE VACANCY
CREATED ON THE METROPOLITAN COUNCIL IN THE
DISTRICT 5 COUNCIL SEAT BY THE ELECTION OF ERIKA
GREEN TO THE FAMILY COURT OF EAST BATON ROUGE
PARISH.**

BE IT RESOLVED by the Metropolitan Council of the Parish of East Baton Rouge and the City of Baton Rouge that:

Section 1. The Metropolitan Council hereby appoints Darryl Hurst to fill the vacancy created on the Metropolitan Council in the District 5 Council seat by the election of Erika Green to the Family Court of East Baton Rouge Parish.

The Presiding Officer announced that a public hearing on the above resolution was in order at this time. Interested citizens speaking on the proposed resolution were Edna Buchanan, Darryl Hurst, Dadrius Landus, Tyra Banks, Alexis Anderson, and Raymond Alleman.

A substitute motion was made by Ms. Banks and seconded by Mr. Cole to appoint Dadrius Landus. A "Yea" and "Nay" vote was called for and resulted as follows:
