The alleged violation occurred on April 7, 2022. Motioned by Mr. Tettleton and seconded by Mr. Shelton to recognize the payment as admission of guilt. Hearing no objections, the motion passed.
- C. Approved/Warning. Citation #4433** issued to **Walmart Louisiana LLC d/b/a Walmart Neighborhood Market #5327**, 9830 Old Hammond Hwy., for violation of the Wine, Beer & Liquor Ordinance, **Section 9:1000 (A)** – License required - (4 Counts). The alleged violations occurred on March 29, 2022. Motioned by Mr. Shelton and seconded by Mr. Tettleton to recognize the conversion of the violations to warnings. Hearing no objections, the motion passed.
- D. Approved. Citation #4678** issued to **Krab Queenz BR LLC d/b/a Krab Queenz**, 5260 Corporate Blvd., for violation of the Wine, Beer & Liquor, **Section 9:1013(6)** – Operating without a permit; **Section 9:1013(4)** – Allowing unlicensed persons to perform services (3 Counts). The alleged violations occurred on March 18, 2022. Motioned by Mr. Tettleton and seconded by Mr. Shelton to recognize the payment as admission of guilt. Hearing no objections, the motion passed.
- E. Approved. Citation #4588** issued to **Easy Stop Food Mart LLC d/b/a Easy Stop**, 2712 Florida Blvd., for violation of the Wine, Beer & Liquor Ordinance, **Section 9:1013(4)** – Allowing unlicensed persons to perform services. The alleged violations occurred on April 12, 2022. Agent Durbin gave a brief description of the incident prior to the citation being issued. Motioned by Mr. Lascaro and seconded by Ms. Sandoz to recognize that the violation did occur, and to assess the statutory fine of \$500.00 and to suspend the license until paid.
