License Renewal Information

Once again it is license renewal time and enclosed is a 2021 license renewal application form. Please be sure that the licensee's name is filled in clearly on the proper blank of the application.

You must submit your completed application and renewal fee to the Mechanical Section by **December 31, 2020** Applications submitted after December 31, 2020 **will** be assessed a late fee of ten dollars (\$10.00) per month until March 1, 2021. If you fail to renew your license before March 1, 2021, you will be required to re-apply in the same manner as a new applicant.

Along with your license renewal application, you must also submit the following documentation:

1. A copy of your state license (**if applicable**) indicating expiration date.
2. A current copy of your insurance certificate. (**City of Baton Rouge must be listed as the Certificate Holder**)
3. A current copy of your surety bond. (**Send original copy with City of Baton Rouge listed as Oblige and MUST include a beginning and ending date**)
4. A copy of your State of Louisiana – Department of Revenue & Taxation Sales Tax Registration Certificate.

NOTE: NO PERMIT APPLICATION WILL BE PROCESSED OR REQUESTED INSPECTIONS MADE IF ITEMS 1 - 4 ARE NOT CURRENT AT THE TIME OF A REQUEST.

General Information

- Please be reminded that state oversight of the rules and regulations pertaining to code enforcement is the responsibility of the Louisiana State Uniform Construction Code Council (LSUCCC). The mechanical and fuel gas code in effect as **February 1, 2018** is the **2015 International Mechanical Code, 2015 International Fuel Gas Code for Commercial and 2015 International Residential**

Code mechanical and fuel gas sections. Codebooks can be purchased on-line at www.iccsafe.org or at local bookstores. The permit office does not sell code books. Deviations from the code are not allowed unless enacted and approved by the LSUCCC. Also, code adoption is the responsibility of the LSUCCC. Please visit their website at <http://www.dps.louisiana.gov/lsucce/> to view the currently adopted codes.

- Permits must be purchased prior to commencement of work or the job is subject to a double permit fee charge. To aid us in processing the permit in a timely manner please supply on the mechanical application the correct address and building project numbers.
- PLEASE NOTE THAT IN OCTOBER OF 2011, THE PERMIT & INSPECTION DIVISION IMPLEMENTED A NEW WEB-BASED PERMITTING SYSTEM CALLED MYPERMITNOW. We encourage each of you to log on to www.mypermitnow.org and click on the “Customer Portal” tab and follow the instructions to create your own unique, secure login. This will allow you to access all of your projects. The system allows you to schedule inspections online as well as receive automated notifications of inspection results. **The system now allows you to E-file and purchase permits from the “CUSTOMER PORTAL”.** Inspection requests via fax will not be accepted. Scheduling of inspections online is the preferred method; however, if you choose to schedule an inspection by phone, you must have both the project number and project address.
- The ordinance now allows for before and after hours non-emergency inspections for a fee of \$150.00 each, payable prior to inspection. All requests for non-emergency inspections shall be made during normal working hours and will be subject to the availability of Inspection Division personnel. The final determination of emergency versus non-emergency status will be by the Building Official or his duly authorized representative. For after hours, emergency inspections, contact the Department of Public Works Dispatcher at (225)389-2070.

We appreciate your cooperation in the past and look forward to working with you in 2018.
