1. ALL SERVICE fees are assessed in addition to the required filing fee(s), and vary depending on item being served. Please contact the Clerk's Office for service fee information.
2. All payments to the East Baton Rouge Parish Sheriff's Office (EBRPSO), Secretary of State (SOS), or other outside agencies must be made by check or money order – CASH PAYMENTS NOT ACCEPTED.
3. Any SERVICE, except small claims suits, on the SECRETARY OF STATE, requires a \$50.00 check made payable to the SECRETARY OF STATE **and** a separate check in the sum of \$39.36 made payable to EBRPSO.
4. Any SERVICE outside of the city limits, but within East Baton Rouge Parish requires a check made payable to EBRPSO. Please contact the Clerk's Office for service fee information, as fees vary according to zip code.
5. Fees for any service outside of East Baton Rouge Parish vary and in some instances require a check made payable to that parish. Please contact the Clerk's Office for service fee information.
6. Any SERVICE of a Writ, regardless of servicing area, may require a deposit in addition to the service fee. Please contact the Clerk's Office for required deposit and/or service fee information.
7. Please note that fees are subject to change for any Constable or Sheriff's Office.
8. You must supply us with all service copies and return copies or you will be charged for copies at our current copy rate. (See reverse)
