The location will be checked during the 30 days to see that the sign remains posted. After the 30 days posting period an application for an alcoholic beverage license will be accepted, provided no formal opposition is received by the A.B.C. Office. Re-zoning cases must be completed and approved by the Metropolitan Council before an application for alcoholic beverage licenses can be accepted.

**Notice of Intent applications are valid for 90 days from the date of application. All applications over 90 days will be subject to a re-application fee. Fees paid for Notice of Intent applications are non-refundable.**
