As a prerequisite to the filing of a Notice of Intent application each applicant shall be required to notify property owners of the proposed location of the business. Notification shall be filed within seven (7) days from the posting of the Notice of Intent at the designed location. Official notice of the posting period of 30 days shall be mailed via regular mail from the Office of Alcoholic Beverage Control to property owners within 500 feet radius of the proposed location as determined by the Planning Commission.

The applicant will be assessed a \$150 fee prior to any such mail out notification. In the event, the application is withdrawn, denied or any other unforeseen circumstances, the fee is **non-refundable**.
